7. The bids will be opened in the presence of Bidders' representatives who choose to attend on **14:00 of 2079/09/07 B.S (22<sup>th</sup> Dec, 2022)** at Tikapur Hospital, Tikapur , Kailali . Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format. The bid security amounting for NRs. **55000.00 (In Words Fiftyfive thousand only)** which shall be valid for 30 days beyond the validity period of the bid.

8. Pre-bid meeting shall not be held.
